#### **New Business**

- 1. Cell Phones in Delaware Courts
  - a. John F reported that Delaware courts are now allowing cell phones to be used in court, as long as not in prohibited areas such as courtrooms

#### **Open Forum**

Theresa Schaedel discussed her prior role working for DOL Unemployment Insurance and then overseeing the Delaware Lottery in 2010 as Revenue and Audit Compliance Manager from 2010-2019, where they audited each casino table game revenue and regulations. After table games were introduced, the office had 50 employees and inspectors trained for 2 years. She was the only person authorized to have unfettered access to all casinos. She was told to ignore findings that staff had found and to change the calculations of gross revenue despite Delaware Code provisions. Starting in 2012, what is reported as table game revenue is not correct according to state law because they were told to change method of calculating revenue. \$2.5 million in uncalculated gross table game revenue that does not match what is in the Delaware Code. Her office was working with Delaware State Gaming Police on the FinCEN finding to monitor potential money laundering. She reported this up the chain of command but was ignored and findings were buried. She reported to DOJ Civil Rights and Public Trust, and they told her to get an attorney and did nothing about the violations. Although she received "Exceeds expectations" on performance reviews for 9 years, she was asked to resign from her position and then offered \$100,000 to leave job and not come back. She filed employment claims against them but nothing was done.
