government. After years of advocacy, a bill (SB 4) to establish the Delaware State Office of Inspector General (OIG) was passed and signed into law. The OIG will stop and deter fraud, waste, abuse, and mismanagement at Delaware state agencies. Additionally, DeICOG's advocacy helped pass critical legislation, for example HB 6 and HB 9, which grants the State Auditor subpoena powers and strengthens "double-dipping" laws in the State of Delaware. DeICOG campaigned against unnecessary multimillion-dollar renovations to Legislative Hall, including stopping construction of an underground tunnel. DeICOG supported efforts to address environmental and health concerns, such as demanding transparency on lead in school drinking water and ensuring public input for a proposed hyperscale data center in Delaware's Coastal Zone. DeICOG has consistently monitored the developments of the federal Corporate Transparency Act to address transparency of corporate and LLC beneficial ownership. DeICOG's outreach includes public access at monthly board meetings and sponsoring special public events, such as Sunshine Week and its Annual Meeting.
